School Uniform Policy 2019-20

Our policy is that all children should wear clothing that is in keeping with a purposeful learning ethos. We also believe that certain school activities are facilitated by specialised and appropriate clothing (including organised events outside normal school hours).

Aims

Our policy is based on the belief that a school uniform:

- promotes a sense of pride in the school
- engenders a feeling of belonging
- is practical and distinctive
- identifies the children with the school
- is not distracting in class (as fashion clothing might be)
- makes children feel equal to one another in terms of appearance
- reflects the sense of both community and diversity that the school takes pride in
- is regarded as suitable, and good value for money, by most parents.

Uniform

All children (Reception – Year 6) should wear:

- Maroon or red sweatshirt or cardigan – (sweatshirts and cardigans can be purchased with the Arnbrook logo from the school office).
- Black or grey trousers, skirt or pinafore dress.
- White, gold or yellow polo-shirt or white shirt (T-shirts can be purchased with the Arnbrook logo from the school office).
- Flat, black school shoes.

Optional Items

- Arnbrook Primary School book bag
- Maroon fleece with Arnbrook logo.

Please note:

During summer months, pupils may wear a red and white pinafore dress and/or or black/grey shorts.

During winter months, children may wear wellington boots to school but these must be stored in a bag and indoor shoes worn whilst inside the building.

PE Kit

For PE all children need:

- White polo-shirt or T-shirt
- Black/grey shorts for indoor PE
- Black/grey tracksuit bottoms or leggings for outdoor PE
- Plimsolls or trainers.
- PE bag

Jewellery & Appearance

On health and safety grounds, we do not allow children to wear jewellery to school (except for small, flat stud earrings and watches). These must be removed for all PE lessons. If earrings cannot be removed then children will be asked to wear tape over them for health and safety reasons. All other jewellery is not permitted, unless permission has been granted by the head teacher following a written request due to religious or medical reasons from the parent/carer.

We do not allow headwear (hats/very large bows/very large headbands) to be worn during class time or inside school buildings, except for religious or medical reasons. In such cases, permission must be granted by the head teacher following a written request from the parent/carer.

Children are not permitted to wear make-up and/or nail varnish to school. Long hair must be tied back securely during PE lessons.

Buying uniform and keeping it safe

All clothing should be clearly labelled with your child's name. This is especially important, as uniform items look similar and can easily be confused for another child's. The school cannot accept responsibility for any lost items.

Uniform with the school logo on can be ordered and purchased at the school office. Suitable school uniform without the school logo on can be purchased from various local supermarkets.

Role of the Class Teachers and Support Staff

- Set a good example in terms of dress.
- Remember that in our respective roles we serve the local community as a set of professionals.
- To remind children to wear school uniform. The class teacher will speak to children and/or parents who do not wear the correct uniform. If they are still not wearing the uniform they are to be referred to a member of the senior management team.

Role of the Senior Management Team

- The role of the senior management team is to ensure that pupils comply with the uniform policy agreed by the governing body.
- The senior management team have a duty to enforce the school uniform throughout the school community, as part of the duty within maintenance of day to day discipline in the school.
- A member of the senior management team will speak to the parents of children who persistently do not wear the correct uniform.
- To ensure the school follows the DfE guidelines regarding school uniform (School uniform Guidance for governing bodies, school leaders, school staff and local authorities September 2013)

Role of the Pupils & Parents/Guardians

- To ensure that their child / children adhere to the school's uniform policy.
- Ensure that they come to school in uniform everyday unless there are special circumstances such as non-uniform days.
- To ensure that all uniform is clearly labelled with the child's name.

Equality

All children have equal access to wearing school uniform regardless of their culture, race, religion, gender, disability or ability. We ensure that the set uniform respects other relevant policies and allows for individual sets of circumstances of all groups and individuals. Ambrook Primary school is committed to creating a positive climate that will enable everyone to achieve their full potential.

The school ensures that school uniform is available for those families who, for different reasons, are unable to purchase school uniform, and has close links with a local clothing charity, Sharewear, for families suffering from clothing poverty. The school ensures parents and carers are aware of the support school can offer in alleviating clothing poverty by publicising this throughout the school year.
